### ELIGIBILITY

Any current member (dues paid by show registration deadline). All work for the juried spring show must be original (no prints except for photography and digital art), not shown in a previous Spring or Fall show (except “Anything Goes”, MAL Studio, or Peters Library walls shows are allowed), and must follow the McMurray Art League standards. All work that meets Standards is accepted. All information and forms are available at <https://www.mcmurrayartleague.com/Exhibits>.

### SHOW DATES AND PLACE

**Friday, April 5** through **Sunday, April 14, 2024**, at The Galleria of Mt. Lebanon, hours: Monday- Saturday, 10 to 7; Sunday, 12 to 5. A reception will be held Saturday, April 6, 3:30-5:00.

### REGISTRATION

You may enter up to **three** pieces of art for the juried show. Please register online from <https://www.mcmurrayartleague.com/Exhibits> and pay online or mail a \$25 check made out to McMurray Art League (entry fee covers both the show and the sale of Artist’s Merchandise, \$10 if you only have Artist’s Merchandise) to Jan Pini at 103 Crabtree Ct., Venetia, PA 15367. (A 15% commission will be assessed for the venue plus a 5% commission to MAL on all items sold, a total of 20% commission.) **Final online registration date is March 29, 2023.** See online MAL Standards document for framing and content. No nudes and/or pieces with religious content. Classwork is permitted but must be the artist’s original composition and execution (see Standards for details). No prints, other than digital art and photography. When choosing pieces to be submitted, keep in mind that screen panel dimensions are 60” tall by 36” wide. **All three of your pieces must fit on a single panel** but might not be displayed together depending on the show layout.

### AWARDS

Up to 6 prizes may be awarded by the juror: First Place (\$100 in cash and/or merchandise), Second Place (\$50 in cash and/or merchandise), Third Place (\$25 in cash and/or merchandise), and three Honorable Mentions (no monetary awards).

### SCREENING

The screening will be done once the show is hung. All work must follow McMurray Art League Standards.

### ARTIST’S MERCHANDISE

You may include up to **six** shrink-wrapped prints, **ten** shrink-wrapped cards/packs, and/or **six** 3-dimensional fine art or artisan craft pieces, even if you have no juried pieces. Each piece should be clearly labeled with the same information as that listed on the inventory sheet. (Use a unique identifying ID comprised of at least your three-character initials plus a number, for example, JCP1, JCP2, etc., for each item. Do not duplicate IDs for different items.) Also include your name, the title of your work, and the price on the label. **Please keep a copy of your inventory sheet for your records and drop off a copy when you deliver your work to the venue on April 4.**

### DROP OFF ART

**Friday, April 4, 7-8 PM** at The Galleria. You are required to hang your artwork. Be aware that pieces may be rearranged to make for a more pleasing appearance of the show. **You must complete an inventory sheet for your show pieces, even if you do not have Artist’s Merchandise.**

### PICK UP ART

**Sunday, April 14, 4-5 PM** at The Galleria. All work **must be signed out** by you (or someone you designate).

### PROCEDURE FOR SITTING

Exhibitors (or their designees) are required to sit for two sessions at the show space. We will be calling you to schedule your sitting times (11-3, 3-7; Sundays 11-2, 2-5). **In case of an emergency, you must plan for someone to sit in your time slot.**
